

Palomino Performance Program

The Palomino Performance Program is designed to award registered Palomino Horse Breeders of America horses for their outstanding performance in other associations and events. The program will reach the Palomino horse market that does not participate in PHBA sanctioned horse shows. This will increase marketability of the horse, increase registration, memberships and award owners for choosing the Palomino horse.

PPP is open to almost any type of activity as long as the competition is sponsored by an organization that keeps official records on the performance of all horses entered in the event.

Reporting Points:

§ One report card must be filled out for each show.

§ One report card can be used for multiple PHBA horses participating in one show.

§ Show secretary or show manager must inspect PHBA registration papers.

§ Show official must fill out placing received and number of entries in class.

- § The show official must sign the report card and state the position they hold.
- § Report card must be postmarked by thirty (30) days after the show or event.

In order for PHBA to include the event in the PPP, the competition must be sponsored by an association, organization or affiliate that has an established recordkeeping, governing body, as well as a representative who will sign a verification form.

Horse Breeders of America (PHBA) All OWNERS AND EXHIBITORS must be a member of the Palomino Horse Breeders of America (PHBA)

To receive any awards you earn from the association and annual enrollment of the PALOMINO horse in PPP is required.

The event secretary or manager should review the PHBA membership and official report form and complete.

Current PHBA members and their registered horses will credits based upon the placing and the number of horses in the competition.

All points earned and accepted are recorded on your horse's permanent show record.

Levels of Achievement in the approved events

Recognition	25 points
Achievement	65 points
Excellance	100 points

A certificate will be mailed for the recognition and achievement awards. An appropriate award will be given at the annual convention for the Excellance award. At the time a horse reaches a level of Achievement, a certificate will be issued.

Palomino Performance Program horses are eligible for PHBA Honor Roll Awards.

Leaders of the PPP event categories will be listed each month in the Palomino Horses magazine.

The competition shows may include, but are not limited to those approved by the associations listed above or their respective state and regional association events.

To be eligible for the Palomino Performance Program:

- 1) The horse must be registered with the Palomino Horse Breeders of America
- 2) The exhibitor/owner must be current members.
- 3) The enrollment form must be completed and filed with the PHBA association for each year of participation.
- 4) Year applies January 1 to December 31 of the current year.
- 5) Must pay a \$15.00 a year (non-refundable) enrollment fee.
- 6) Nominated horse(s) must be PHBA registered.
- 7) Nomination form(s) requests need to be sent to the PHBA.
