

□ Clear copy of the front and back of breed association papers – PHBA checks the written markings against the illustrated markings (if on breed papers). Papers must be in your name. They may be submitted at a later time, however they are required before registration can be completed.

THESE ITEMS MAY BE REQUIRED

- □ Signature Authorization Form Required for horses being registered in a farm, ranch, business, etc.
- □ Relationship Authorization Form Required for horses registered in an individual, or family owned farm, ranch, business, etc.
- □ 35mm Pictures or 35mm quality computer generated photographs printed only on photo quality paper- Clear full view front, back, each side, as well as any close-ups of any additional markings, scars, brands, etc. Polaroids or Self-Developing photos are not recommended. Photos submitted on a disk or e-mailed are acceptable.
