**ELIGIBILITY/REQUIREMENTS FROM THE 2022 PHBA WORLD SHOW PREMIUM (page 1):**

**REQUIREMENTS**

~~Horses and exhibitors do not have to pre-qualify to be eligible to participate in this show.~~ All Owners and Exhibitors must be current members to show and horses must be registered with PHBA.

***Replace with All horses (palomino and palomino bred) must qualify (exception for weanlings, yearlings and two year olds) to participate at the PHBA Open/ Amateur World Championship Show. In order to qualify to compete at the PHBA Open/Amateur World Show, all horses must show to four (4) different judges in PHBA approved classes at PHBA affiliate sponsored shows during the qualifying period.***

***Horses may be shown in any state, regardless of residence to qualify. The qualifying period will be from May 1<sup>st</sup> through April 30<sup>th</sup> for a world show scheduled in July. When making entries for the PHBA World Championship Show, the exhibitor will provide verifiable proof of having shown to the required number of judges.***

***Horses and exhibitors showing only in youth classes do not have to pre-qualify to be eligible to participate in the PHBA Youth World Championship Show.***

Possible financial impact to PHBA:

Increased revenue per show fee of \$7.00 per horse PHBA national show fee. For example, for a small double judged show with just a few horses with an increase from 5 to 15 horses:  $10 \times \$7 \times 2 = \$140.00$ . At a larger four judge show with 45 horses increasing to 60 horses:  $15 \times \$7 \times 4 = \$420$ . Multiplying these numbers by number of annual shows (using an average) could conservatively result in additional \$10,000 plus in revenue to PHBA from this fee alone. There could be other revenue generated by increased memberships, registrations and transfer fees.

Increase in the prestige factor at the World Show could result in additional entries generating increased entry fees, stall fees and office fees. Dollar amount unknown.

**REQUIREMENTS**

~~Horses and exhibitors do not have to pre-qualify to be eligible to participate in this show.~~ All Owners and Exhibitors must be current members to show and horses must be registered with PHBA.

Replace with ***All horses (palomino and palomino bred) must qualify (exception for weanlings, yearlings and two year olds) to participate at the PHBA Open/ Amateur World Championship Show. In order to qualify to compete at the PHBA Open/Amateur World Show, all horses must show to four (4) different judges in PHBA approved classes at PHBA affiliate sponsored shows during the qualifying period. Horses may be shown in any state, regardless of residence to qualify. The qualifying period will be from May 1<sup>st</sup> through April 30<sup>th</sup> for a world show scheduled in July. When making entries for the PHBA World Championship Show, the exhibitor will provide verifiable proof of having shown to the required number of judges.***

***If the above qualifying requirements are not met, a palomino or palomino-bred can still be entered for a higher entry fee per horse ½ which will be retained by PHBA and ½ which will be distributed by PHBA to the APA of the horse owner (if the owner does not have a designated affiliate, 100% of additional entry fee will be retained by PHBA). Horses entered in Open and/or Amateur classes, will require an additional \$200 fee.***

***Horses and exhibitors showing only in youth classes do not have to pre-qualify to be eligible to participate in the PHBA Youth World Championship Show.***

Possible financial impact to PHBA:

Increased income to PHBA for horses entering only the World Show and no affiliate shows is unknown but estimating at least 10 horses or more are in this category. For a local affiliate, a \$100 could pay for meals for a judge or for a show approval or show awards. For some affiliates, this could be the difference between profit or loss for a show. For PHBA, 10 X \$100 = \$1000 would pay for the extra administration of the fee. If more than ten horses are exhibiting at the world without showing at local shows, the generated income would be more.
