# Annual Meeting Minutes March 16, 2013

### **Opening:**

The annual meeting of the PHBA Board of Directors was called to order at 8:22 AM on March 16, 2013 in Tulsa, Oklahoma by President, Melonie Furnish.

A quorum was established.

A motion was made by Benham Stewart and 2<sup>nd</sup> by Mary Ann Felitz to approve the minutes from the last annual meeting, motion passed.

The Treasurer's report was presented by Ann Jones, PHBA Secretary/Treasurer.

A motion was made by Benham Stewart and 2<sup>nd</sup> by Ken McDowell to include the Treasurer's report in the minutes, motion passed

A motion was made by Marleen Cowie 2<sup>nd</sup> by Eric JayJohn by to accept the APA/Membership report as given – motion passed

Dick Shanahan, the financial advisor for PHBA, came to speak about the Audit. In addition, the committee requests the rule be immediately implemented. Lynn seconded the motion. Motion passed.

3352-A, B, & C: Proposed change adopted with additional language designating that coat color will be used as a tie-breaker. Rule to read as follows:

3352. Judging Percentages. In all halter or breeding classes, the following percentages shall be used:

A. Ninetv (90%1 percent conformation.

B. Ten (10%) percent manner and way of going.

Color will be used as a tie-breaker.

A motion was made by Benham Stewart,  $2^{nd}$  by Cliff Harden to deny the rule change proposal for Halter – Rule 3352 –

  - Eric JayJohn explained the pending vote in detail in an effort to clear the confusion.
  - The ballots were then opened and the results of the vote was 45 yes, 34 no, motion failed to pass

A motion was made by Benham Stewart to reconsider the vote, 2<sup>nd</sup> by Howard Rea – motion passed

The motion to deny the rule change for halter – rule 3352 was brought back to the floor for revote – the results were 13 yes, 66 no - motion rejected

A motion was made by Nancy Ayers to accept the motion as submitted by the show committee,  $2^{nd}$  by Debbie Wall –

- A motion to amend Nancy Ayers motion was made by Benham Stewart, 2<sup>nd</sup> by Howard Rea to halter classes would be judged based on 10 % color 80% confirmation & 10% way of movement and manners, motion passed
- The vote on the motion as amended to read 80% confirmation, 10% color & 10% way of movement and manners, motion passed

A motion was made by Benham to deny the motion take effect immediately, 2<sup>nd</sup> by Alda, motion passed

A motion was made by Benham  $2^{nd}$  by Howard Rea to approve Hunter in Hand penalties, motion passed

Hunter In Hand Penalties: Adopted the proposed penalties to be added into the Hunter In Hand class as presented to the committee by Howard Rea on behalf of the judges committee. (Language included with minutes and report as an attachment.)

Hunter In Hand penalty points - Rea provided the committee with the newly created penalty points.

- one point Break of gait at a walk or trot for two strides or less
- Three Point Break of gait at a walk or trot for more than two strides Knocking over cone /
- Five Point Refusal
  - o Buck, rear, strike, or kicking
- Disqualification
  - o Fall of horse or handler
  - o Become detached from horse
  - o Off Course

A motion was made to completely remove the Tennessee Walkers from PHBA by Benham Stewart, 2<sup>nd</sup> by Bill Parker, motion passed

#### From the Show Rules Committee:

Animal Welfare Action: Adopted the recommendations as approved by the animal welfare committee to eliminate the show rules pertaining to the Tennessee Walking Horse, with the understanding that the PPP flyer be modified also. (Requires a 75% affirmative vote of the National Directors – proposed changes not submitted prior to 120 day deadline)

The action would delete the following: Rules 4721 thru 4725 in their entirety, and the youth and amateur walking horse class listings in rules 4801 and 4901. The handbook needs to be checked for any other affected rules and corrected accordingly.
