Rule 3001. Show Application Fee. \$50 per approval/Judge fee for APA shows or \$60 per approval/judge fee for NON-APA shows must be enclosed with each show approval. Show approvals must be postmarked at least 120 DAYS prior to the date of show.

Rule 3006. If posted marked less than one hundred and twenty (120) days but more than sixty (60) days add \$60 per judge late penalty fee. Rule 3007 No Refund on show application fee(s).

Rule 3003. The application must be accompanied with a complete list of all classes to be offered at the show.

PENALTIES FOR LATE SHOW RESULTS AND FEES

Rule 3051: "Failure to submit show results will result in a \$ 50 per show per judge fee after the first 10 day period. An additional \$75 will be added per show per judge each 10 days the horse show is late over and above the first 10 days".

Rule 3053: The payment of the appropriate administrative and drug testing fees which are not received within ten (10) calendar days will be penalized according to the time frame found in 3053 A and B.

Rule 3058. The administrative fee of \$5, per horse, shall be charged only once during any given show. Additional fees should not be collected for the same horse showing in youth, amateur or amateur novice competition. 01/2016
