Membership begins the day the membership form and payment are received by the WCHA Office or by a WCHA Event Show Office representing the WCHA and **expires December 31** of the calendar year of purchase.

SECTION A: Non-Pro Applicants ONLY Complete this Section

NON-PRO STATEMENT OF ELIGIBILITY: Exhibitor has not shown, sold a horse for a third party, judged, trained or assisted in training a horse for remuneration, including commissions, nor received compensation for instructing another person in riding, driving, training, or showing a horse for five years previous to application for Non-pro membership. Payment of entry fees and/or by anyone other than the Non-pro, his/her immediate family, or a corporation, partnership or other business entity in which the Non-pro and/or a member of his/her immediate family are the sole and only owner, shall be considered remuneration. A Non-pro cannot be an approved horse show judge for any association or have judged an open, 4-H or breed show for the past 60 months. Violations will be grounds for forfeiture of all prizes, prize monies and of all fees paid and possible suspension from the WCHA.

"I have read and I understand the WCHA Non-Pro Eligibility Definitions and Rules above and truthfully state that I am eligible as a Non-Pro. I understand that the full responsibility concerning my eligibility rests solely on me. The WCHA, it's officers, directors, staff and show staff are not responsible for the burden of proof for my eligibility. Should I be found not eligible for said division after competing; all money, prizes, points and awards shall be forfeited and returned to the WCHA office upon notification to me for redistribution to eligible entries."

SECTION B: MEMBERSHIP DEFINITIONS

Regular Membership – Full Membership Privileges – Restricted to one person, carried in that person's legal name only, providing full privileges of the WCHA including eligibility to participate in WCHA's Open Division of shows and other WCHA activities that require individual membership.

Lifetime Regular Membership – Established in the name of a joint, assumed or trade names, corporate, partnership (general or limited), syndicate or joint venture or decedent's estate, trust, guardianship or other custodial legal entity shall have the right to designate one individual to vote and exhibit as if they had an individual membership. Such designation is for the life of the membership.

Joint Membership – A combination of two persons such as a husband and wife, includes such designations as John and Jane Doe, John or Jane Doe, John and/or Jane Doe and John/Jane Doe

Assumed or Trade Name Membership – Person or persons or artificial legal entity, such as A. Smith dba/Smith Ranches; Smith Ranches, a sole proprietorship of A. Smith; or any other designation not being the legal name of the person or artificial legal entity.

Corporate – Corporations in good standing in the state or country of their incorporation, the officers, representatives, shareholders and all beneficial owners.

Partnership (General or Limited) – Partnerships in good standing in the state, province or country of their organization, the partners, limited partners, representatives and all beneficial owners.

Syndicate or Joint Venture – Syndicates or joint ventures in good standing in the state, province or country of their organization, the representatives and all beneficial owners.

Decedent's Estate, Trust, Guardianship or other custodial legal entity – Decedent's estate, trust, guardianship, or other custodial legal entity, the person for which the entity is created, his representative and all beneficial owners or beneficiaries.
