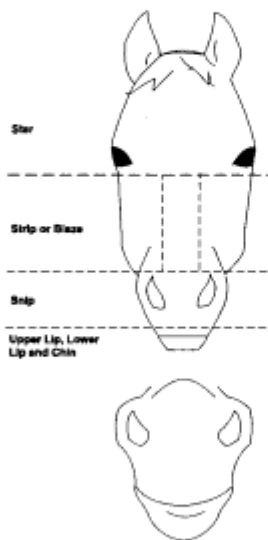

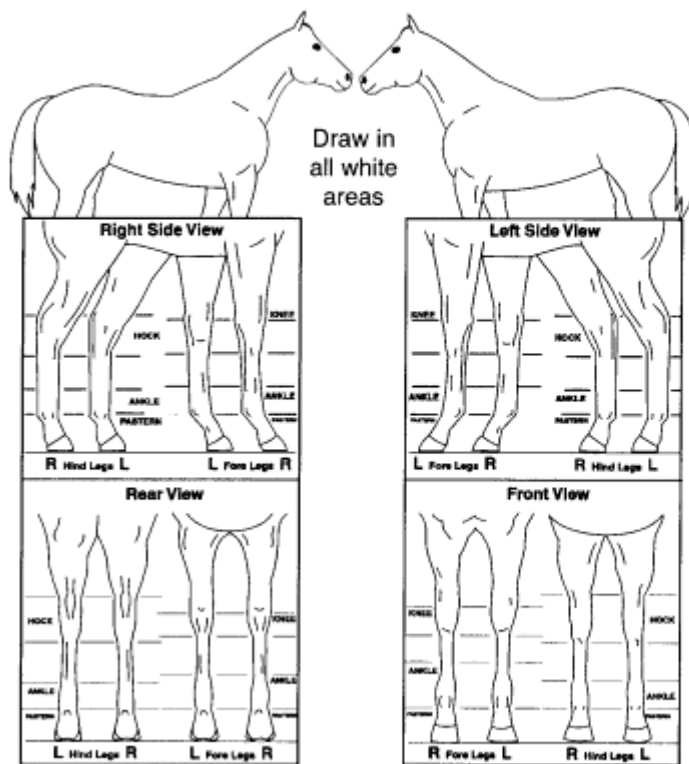

**THE ITEMS LISTED BELOW ARE REQUIRED IN ORDER TO COMPLETE A REGISTRATION**

- Completed registration application in original ink - make sure to answer ALL of the questions.
- Membership fees - Must be a current or joining member, or pay non-member registration fee. The name needs to be printed exactly as you want the PHBA Certificate of Registration to reflect.
- Registration Fees - Must be sent in for the amount required for your horse's year foaled (PHBA uses January 1 as his/her birth date no matter when s/he was foaled.)
- Clear copy of the front and back of breed association papers - PHBA checks the written markings against the illustrated markings (if on breed papers). Papers must be in your name. They may be submitted at a later time, however they are required before registration can be completed.
- 35 mm Pictures or 35mm quality computer generated photographs printed only on photo quality paper - Clear full view front, back, each side, as well as any close-ups of any additional markings, scars, brands, etc. Polaroid's or Self-Developing photos are not recommended. **Photos submitted on a disk or e-mailed are acceptable.**

**THESE ITEMS MAY BE REQUIRED**

- Signature Authorization Form - Required for horses being registered in a farm, ranch business, etc.
- Relationship Authorization form - Required for horses registered in an individual, or family owned farm, ranch, business, etc.
