REGISTRATION AND TRANSFER RULES ELIGIBLE HORSES

521. PHBA recognizes the following breed registries, relative to the registration of Palomino horses. Horses registered in these associations must meet the appropriate qualifications including but not limited to body coat, skin, mane, tail, and white markings as stated elsewhere in the Registration and Transfer Rules.

T. Pony of the Americas (POA)

COMMITTEE: ACCEPT; request for immediate implementation NATIONAL DIRECTOR: SENT BACK TO COMMITTEE

U. North American Peruvian Horse Association (NAPHA)

PALOMINO BRED

554. A PB must be produced from the breeding of at least one PHBA registered parent <u>or grandparent</u> (not including the PB registry), and the other parent is required to be from the list of PHBA recognized breed registries. Its sire <u>or grand sire</u> and/or dam <u>or grand dam</u> are registered in PHBA. The horse shall meet all previously mentioned registration requirements.

A. Hardship Clause: The owner of an eligible non-palomino horse, whose palomino parent/<u>grandparent</u> (must meet PHBA registration guidelines) is not registered with PHBA, may seek registration if his/her horse using one of the following options.

1) Living palomino parent/grandparent: The owner of the eligible non-palomino horse, may purchase one annual membership for the owner of the parent/grandparent horse and the registration of the parent/grandparent horses (must meet PHBA registration guidelines), if the parent/grandparent horse's owner is agreeable via letter documentation.

Requirements:

a) Copies of recognized breed association paper(s) stating palomino color and

b) Pictures of parent/grandparent horse as stated in Rule 507.

2) Deceased palomino parent/grandparent: documentation of registration in a PHBA recognized breed, deceased and color must be provided stating such. Appropriate fees must accompany documentation for registering applicant.

A multiple-judged event consists of three shows on one day with three (3) different judges not to exceed three judges in the arena at any given time. <u>a split-combined format show with a maximum</u> of 3 judges. No APA show may have more than 2 judges in the arena at a time unless they are a holding a split-combined show.

C. Shows with special circumstances may apply to the Executive Board for an exception for the number of judges judging in the arena at the same time. Such application must be submitted in writing. The World Show and other National level shows shall not require a variance for up to five (5) judges in the pen. All other variance request applications must be submitted in writing and require an additional \$100 non-refundable application fee.

Bars must be round, oval, egg-shaped, smooth and unwrapped metal of fivesixteenth (5/16") to three-fourth (3/4") inch (8-10 mm) in diameter, measured one (1") inch (25 mm) from the cheek. However, wire on the sway bars (above the bars and attaching to the spade) of a traditional spade bit is acceptable. They may be inlaid, but must be smooth or latex wrapped. Nothing may protrude below the mouthpiece (bar), such as extensions or upward prongs on solid mouthpieces, <u>aside from the rivet that anchors a pivoting port</u>. A three piece, connecting ring of one and onefourth (1 1/4") inches (32 mm) or less in diameter, or a connecting flat bar of three-eights (3/8") inches to three-fourth (3/4") inches (8-10 mm), measured top to bottom with a maximum length of two (2") inches (50 mm), which lies flat in the horse's mouth is acceptable;

ST DIVISION ENGLISH CLASSES 3335. Bits. An English snaffle (no shank), pelham, kimberwick and/or a full bridle (two reins), all with cavesson noseband and plain leather brow band is required.

A. In reference to mouthpieces, nothing may protrude below the mouthpiece (bar) <u>aside from the rivet</u> <u>that anchors a pivoting port</u>. Solid and broken mouthpieces must be five-sixteenth (5/16") to three-fourth (3/4") inch (8 mm to 20 mm) in diameter, measured one (1") inch (25 mm) from the cheek and have a port no higher than one and one-half (1 1/2") inches (40 mm). Snaffle bit ring may be no larger than four (4") inches (100 mm);

3481. Scoring. Scoring shall be on a basis of zero (0) to one hundred (100), with an approximate breakdown as follows:

A. 90-100: an excellent performer and good mover that jumps the entire course with cadence, balance and style;

B. 80-89: a good performer that jumps all fences reasonably well; an excellent performer that commits one or two minor faults; **smooth**.

C. 70-79: the average mover that makes no serous faults, but lacks the style, cadence and good balance of the scopier horses; the good performer that makes a few minor faults; **out of rhythm riding** (minor miss/"chips"), additional minor faults (light rub/rubs).

D. 60-69: poor movers that make minor mistakes; cross canter, fair or average movers that have one or two poor fences but no major faults or disobediences. Cross canter or no change (60), extra stride in a measured line (61-64), multiple distance mistakes, rail on lip of cup/displaced rail,

E. 50-59: a horse that commits one major fault, refusal, trot or drops a leg; <u>Trot, poor manners,</u> dangerous jumping, extra stride in and out, and elimination of a stride in a measured line. Hang a leg or drop a leg. **F. 30-49:** a horse that commits two or more major faults, including front or hind knockdowns and refusals, or jumps in a manner that otherwise endangers the horse and/or rider; <u>Disobedience (refer</u> to disobedience chart).

G. 10-29: a horse that avoids elimination but jumps in an extremely unsafe and dangerous manner <u>as</u> to preclude a higher score, 2 disobediences.

If horse takes one step backwards it is a refusal. After refusal, if horse is moved toward the obstacle but does not attempt to jump, it is considered another refusal. 2. Run-out. A run-out occurs when the horse evades or passes the obstacle to be jumped; jumps an obstacle outside its limiting markers; or when the horse or exhibitor knocks down a flag, standard, wing or other element limiting the obstacle (without obstacle being jumped). 3. Loss of Forward Movement. Failure to maintain trot, canter or gallop after crossing starting line, except when it is a refusal, a run- out or when due to uncontrollable circumstances, such as when an obstacle is being reset. 4. Unnecessary Circling on Course. Any form of circle or circles, whereby the horse crosses its

4. Unnecessary Circling on Course. Any form of circle or circles, whereby the horse crosses its original track between two consecutive obstacles anywhere on course, except to retake obstacle after refusal or run-out.

3484. Elimination.

A. A total of three (3) disobediences which include any of the following: refusal, stop, runout, extra circle;

- **B.** Jumping an obstacle before it is reset;
- **C.** Bolting from ring;
- **D.** Off course;
- E. Jumping an obstacle not included in course;

F. Deliberately addressing an obstacle.

G. Failure to trot the horse in a small circle on a loose rein for soundness, after jumping the fence, while still mounted and prior to leaving the arena;

H. Fall of horse and/or rider;

6242. Suggested Scoring System. Competition round begins immediately when they come through the in-gate. Scoring may shall be on a basis of 0-100, with an approximate breakdown as follows:

A. 90-100: Excellent equitation, position and presentation; meets all fences squarely and at proper distance. Uses all options to their advantage.

B. 80-89: Minor equitation faults, i.e., long, weak distance, deep distance, one step landing at countercanter. Rider still maintains a quality ride, smooth

C. 70-79: More problems occur, equitation suffers, i.e., rounded shoulders, heels are not down, hands incorrect, lacks the style and presence. One major fence problem, i.e., chip with a ride up the neck, or discreet swap out, jumping off one side of jump. No dangerous fences, not a flowing course, out of rhythm riding (minor miss/ "chip"), additional minor faults (refer to minor fault chart).

D. 60-69: Major equitation faults, poor body position, loose legs and seat, failure to obtain or maintain trot to a trot fence approach, 2 or 3 misses at the fence.

E. 50-59: Refer to major fault chart.

F. 40-59: Breaking to a trot while on course, counter-canter or cross-canter at ends of arena, missed lead changes, loss of stirrup, dropping a rein, extra stride in combination.

40-49: Disobedience (refer to disobedience chart)

F. 10-39: Rider avoids elimination, one or two refusals disobediences, knockdowns, dangerous fences, accumulative major faults.

Move this to end of what appears as PHBA Rule #6239 B. If a rider steps into the obvious wrong lead for one or two strides only before or on the courtesy circle, it is noted on the score sheet, which may be used as a tie breaker in the event of a ride of equal quality and score.
