Proposed Rule: RULE CHANGE

**Recommendation for change:**

I am recommending a CHANGE to the category MISCELLANEOUS CATEGORY under the section HUNTER IN HAND

**The old rule reads:**

3384. There should be an annual PHBA high point award in this class.
- A. Points in this class shall not count toward PHBA Year-End High Point Awards or towards the 100 point novice status.
  - B. APA's shall decide whether points in this class shall count for High Point Awards at their shows.

**The NEW RULE shall read:**

3384. There should be an annual PHBA high point award in this class.
- A. Points in this class **SHALL COUNT TOWARDS** PHBA year end high point awards, however they shall NOT count towards the 100 point novice status.
  - B. {Stays as is}

**Justification for the change and impact thereof:**

My clients and I have shown in many many shows over the last 5 years including the world show every year. At the world show, the hunter in hand COUNTS TOWARDS the Golden Horse Award yet at all the state affiliate shows the only thing that class is for are the points for an additional national class high point award.

The class either needs to COUNT towards the all-around high point awards or it needs to be dropped from the list of classes completely. It adds a lot of time to the shows and has no merit.

IF the decision is to drop the class completely, then it should also be dropped from the world show. One way or another it either needs to count towards the annual high point award or get rid of it.

Makes no sense to me to have it at the World Show and IT COUNTS IN THE ALL-AROUND, but in the national association (which governs the world show, I believe) all-around high points, it means nothing.
