Committees are free to discuss other proposed rule changes but the assigned committee's recommendation is that which will be used during voting at the Board of Directors Meeting.

521. Add U. - POA, Pony of the Americas, only those with A. Permanent POA registration papers that state height of 56", or B. ID Pink POA registration papers that state height of 56.1" or greater.

Reasoning:

Allows another breed whose solid-colored palominos, with height and color qualifications, to register and show with PHBA. Also allows base coat color palominos to register under Palomino Bred, with height qualifications.

POA papers list the height and color of the POA on their papers once they receive permanent papers (see attached example). That's why we list the description as A. PERMANENT papers in the rule proposal. We would only accept those that list a height of 56" (14H). Once a POA measures over 56", at any age, they are given ID PINK papers (see attached example), hence the wording B. ID Pink in proposal.

When talking with their registration chair, they were very excited to possibly have a place for their pink papered horses to show because PINK papered POA's can't show in POA shows. They are considered breeding stock only. We would be giving them a place to show.
