REQUIRED FOR REGISTRATION

- ☐ **Completed registration application** in original ink
- ☐ **Membership Fees** – Owner (s) must be a current or joining member, or pay non-member registration fee. The name needs to be printed exactly as you want the PHBA Certificate of Registration to reflect.
- ☐ **Registration fees** – Must be sent in for the amount required for your horses' year foaled (PHBA uses January 1 as birth date no matter when the horse was foaled).
- ☐ **Clear copy of the front and back of the breed association papers** – PHBA checks that written markings against the illustrated markings (if on breed papers). Papers must be in your name. They may be submitted at a later time; however they are required before registration can be completed.
- ☐ **Photographs** – Owner may supply four (4) color photographs (front, back and each side of horse). These pictures become property of PHBA. Include up-close pictures of any additional markings, scars and/or brands. Photos submitted on a disc or e-mailed are acceptable.

THESE ITEMS MAY BE REQUIRED

- ☐ **Signature Authorization Form** – Required for horses being registered in a farm, ranch, business, etc.
- ☐ **Relationship Authorization Form** – Required for horses registered in an individual or family owned farm, ranch, business, etc.
